

ORDER

Leave to Appeal was granted on December 2, 2022, on the question of whether the Assessment Review Board erred in disposing of the proceeding without a hearing in the absence of the consent of all statutory parties given section 4.1 of the Statutory Powers Procedure Act, RSO 1990, c S.22.

THIS COURT ORDERS that:

- 1. The following decisions of the Assessment Review Board be set aside:
 - a) Decisions dated April 24, 2020, for the 2018 and 2019 taxation years bearing decision numbers 2815327 and 2815328;
 - b) Decision dated August 21, 2020, identified with reinstatement number 20-040;
 - c) Decision dated January 21, 2022, under file number RD 20-064; and
 - d) Decision dated April 14, 2022, under file number RD 20-064A.
- 2. Assessment roll number for the property located at 1509-1531 Merivale Road in the City of Ottawa be amended to provide an assessed value of the property of \$5,200,000 (with \$4,711,200 in the commercial property class and \$488,800 in the shopping centre property class) for the 2018 and 2019 taxation years;
- 3. Each party shall bear its own costs for the within appeal.
